**CORRIGENDUM**

2. The technical bid will be opened on **11.01.2024 at 11:30 A.M.**
3. The Pre-Bid queries can be submitted upto **08.01.2024 till 5 P.M.** to the office of Mo School Abhiyan Parichalana Sangathan via email ([office@moschool.in](mailto:office@moschool.in))
4. The pre bid meeting is scheduled to be held on 09.01.2024 at 12 noon through virtual mode.
5. Responses to pre bid queries will be uploaded in web site of Mo School Abhiyan Parichalana Sangathan i.e. [www.moschool.in](http://www.moschool.in) by 5 P.M. on dated 09.01.2024.
6. Bid Security (also known as earnest money) is to be obtained from the bidders except Micro Micro and Small Enterprises (MSEs) and start-ups as per Odisha MSME Development Policy, 2016 and start-ups as defined under Odisha start-ups Policy, 2016 and F.D. Dept. office memorandum No. 13290/F dated. 20.04.2013 issued supplementary guidelines for procurement of goods from local MSEs later vide FDOM No. 21926/F dated. 12.08.2015. The bidders (Except Micro Micro and Small Enterprises (MSEs) and start-ups) shall submit Earnest Money of INR 8,00,000/- (Rupees Eight Lakhs only).
7. Mode of submission of proposal- Speed Post, Registered Post & Courier service during the office hour only.
8. Eligibility Criteria of Section "F" (Financial Capacity) – Minimum average annual turnover of Rs. 3.5 Crores over last five financial years ending up to FY 2022-23 of undertaking Event Management activities. (Which was Rs. 8 Crores previously).
9. Evaluation Criteria of Section "G" Point 1 has been revised as – Minimum average annual turnover of Rs. 3.5 Crores over last five financial year ending upto FY 2022-23 of undertaking Event Management activities:
